WGSG Monthly Draw (formerly known as the 100 Club)

The PFA invites all parents/carers to join the WGSG Monthly Draw.

- What is it? A monthly draw with a cash prize.
- Who benefits?
  - ✓ The school and therefore your daughter.
  - ✓ You, as a participant, would have the chance of winning a cash prize each month:
    - o January to November (excluding August): 1st Prize £30, 2nd Prize £15
    - o December Christmas Special Draw: 1st prize £100, 2nd prize £50, 3rd prize £20
- How does it work? Two numbers are drawn at random for each draw (three for December) and the winners are notified by email and asked to collect their prize from the school office. The winners will also be announced on the school blog.
- How much does it cost? £12 a year for one number but feel free to subscribe for more than one number if you like to improve your odds!
- How can I play? Just follow the two simple steps below:
  - 1. Complete the attached MEMBERSHIP FORM and return it to the school office marked for the attention of the PFA Treasurer. It is important that you complete and submit this form to us so that that we are able to communicate to you any winnings AND
  - 2. Pay for your number or numbers <u>for the full year</u>, upfront via Annual Standing Order (i.e., £12 per share per annum) by either:
    - completing the attached standing order form and returning it to your bank; or
    - through online banking to the WGSG PFA account (Sort Code 60-06-33 Account No. 07513550)

In both cases, <u>please use your daughter's initial and surname as reference</u> so we can tie your payment to your entry.

Please submit your applications and payments by **30<sup>th</sup> September** at the latest to be included in the September draw. Once your completed slip and payment has been received, you will receive an e-mail confirmation with your allocated number or numbers.

- 1. The club operates on an annual basis from 1<sup>st</sup> September each year.
- 2. Each number will be £12 per annum.
- 3. Payment is made by Standing Order each September. NB: Please make sure that the Standing Order is set-up for yearly payments of the appropriate amount (£12 per number). When your daughter/son leaves the school, please ensure that you cancel the Standing Order, and advise the PFA accordingly.
- 4. Numbers will be drawn each month (except for August) with a larger prize in December.
